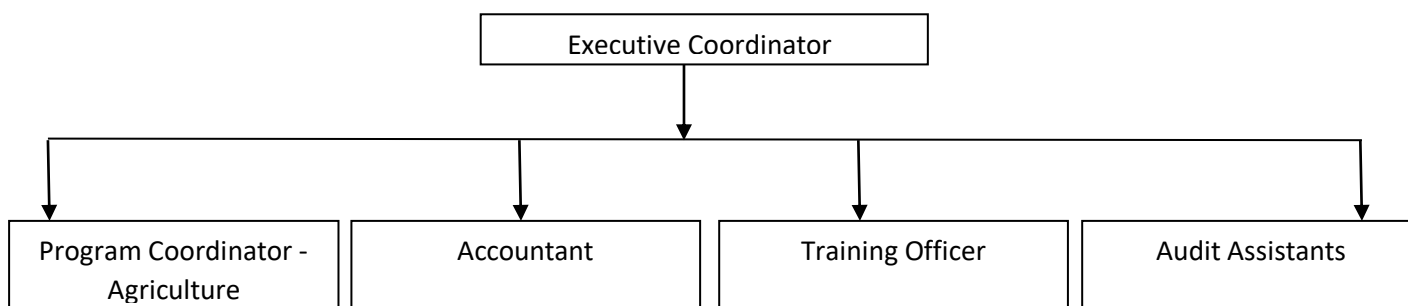

Trustees & Executive Team

The TRUST leadership team remained the same as the previous year with Mr. R. Gopikanthan as Managing Trustee of the organization, and Dr. Aishwarya Arjun and Mrs. M. Sampooram staying on as trustees. Mr. R. Venkatachalam, the former Managing Trustee, remains a consultant for TRUST. Finally, Miss. M. Indhumathi, the Executive Coordinator, reports directly to the Managing Trustee.

TRUST Objectives:

- Support non-governmental organizations with similar goals to TRUST such as the Women's Self-Help Initiative (WSI)
- Ensure that TRUST's agricultural resources provide sufficient resources to assure continued funding for the organization
- Finalize plans for construction of the TRUST office and a senior retirement home for the proposed program

TRUST Consultation Program

One of TRUST's focuses is on aiding other community-based organizations that provide loans and other benefits to poor women. At present, TRUST primarily works with the Women's Self-Help Initiative (WSI), an organization with goals for women's development and empowerment that are comparable to TRUST's own aims.

Among other things, TRUST, through the consultation program, has been helping WSI secure loans from ICICI Bank to promote female entrepreneurship through micro-credit. The following table provides more detail about the loans which we have had the opportunity to make possible.

TRUST Insurance Program

TRUST has partnered for many years with the Life Insurance Corporation of India (LIC) to provide low-income women and their families with at least minimal insurance coverage. This program provides poor families in our project areas with information about and access to LIC schemes such as Jeevan Madhur (life insurance plan) and Jeevan Mangal (term assurance plan). The Jeevan Mangal program was transferred to WSI once they received approval from LIC. TRUST assists by making recommendations and helping them make claims. The following tables provide further detail.

Other TRUST Activities

Karumandurai Land

Kilakkadu:

- The well was cleaned out, the land tilled and aricanut plants fertilized in June 2018.
- The aricanut grove at Kilakkadu has been leased out for one year in November 2018.

Sellankurichi:

- Sellankurichi land (2.50 acre) was leased out in May 2018, and the land was tilled in October 2018.
- Unwanted branches were removed from teak trees in October 2018.

Karumapuram Land

- The Karumapuram land patta was transferred to TRUST's name.
- The building Bhoomi pooja took place in November 2018, and a temporary shed was built.

Conclusion

TRUST has successfully worked on those things it set out to accomplish during the reporting year in terms of it consultation for and training of other non-governmental organizations. There has also been some progress made in beginning the construction of the TRUST office and senior retirement home, and acquiring the patta for that land has been successful. However, TRUST hopes to progress further with its plans for the Karumapuram land in the next year.
